

Demographic Analysis and Strategic Ministry Implications: Tyrone and Peachtree City, Georgia (2015-2035)

1. Introduction

1.1 Purpose and Scope

This report provides a comprehensive demographic analysis of the municipalities of Tyrone and Peachtree City, located in Fayette County, Georgia. The analysis focuses on population dynamics, psychographic characteristics, and lifestyle trends observed over the approximate period of 2015 to 2025, with projections extending to 2035. Key demographic categories examined include age distribution, household composition, income levels, poverty rates, racial and ethnic diversity, educational attainment, religious affiliation, worldview outlook, and housing tenure. Additionally, the report incorporates an assessment of primary and secondary school ratings within each municipality.

The primary objective of this report is to equip the church leadership team with data-driven insights to inform strategic decisions regarding outreach initiatives, ministry focus areas, community engagement approaches, and the potential development of new congregations specifically aimed at reaching unaffiliated populations within these communities.

1.2 Methodology

This analysis synthesizes data from multiple sources, primarily relying on the U.S. Census Bureau's American Community Survey (ACS) 5-Year Estimates, specifically the 2019-2023 dataset, to provide the most current detailed demographic snapshot.¹ Where available, comparisons are drawn with earlier Census data (e.g., 2010 Census) to illustrate trends over the past decade.¹ Note: Direct access to specific 2011-2015 ACS Data Profile tables for these municipalities via provided links was unsuccessful⁴, thus limiting direct comparison to that specific dataset; the 2019-2023 data serves as the primary baseline for recent conditions.

Population projections are derived from forecasts by the Atlanta Regional Commission (ARC) and the Georgia Governor's Office of Planning and Budget (OPB).¹² Religious affiliation data for Fayette County is sourced from the Association of Religion Data Archives (ARDA) 2020 U.S. Religion Census.¹⁴ School ratings are based on data compiled by Niche.com, utilizing U.S. Department of Education statistics and user reviews.¹⁵ Psychographic and lifestyle insights are informed by regional reports and

community surveys, including studies focused on nearby areas like Fairburn and Peachtree City's own resident surveys.²² National and state-level worldview trends are analyzed using data from Barna Research and Pew Research Center.²⁵

The analysis integrates these diverse data streams to build a holistic profile of each municipality, focusing explicitly on the implications for church leadership and ministry strategy.

2. Executive Summary

Tyrone and Peachtree City, neighboring municipalities within Fayette County, present distinct yet overlapping demographic landscapes with significant implications for church ministry. Both communities are characterized by high affluence, exceptional educational attainment, and highly-rated public schools, making them attractive to families.

Tyrone emerges as a smaller, rapidly growing town with exceptionally high median household income (\$133,773) and very low poverty (2.1%). It exhibits significant racial diversity, with substantial White (55.2%) and Black (31.3%) populations, alongside smaller but present Asian and Hispanic groups. High homeownership (91.7%) and a notable percentage of remote workers (23%) suggest stability and a professional workforce. Strategic considerations for Tyrone include engaging high-capacity individuals, developing culturally relevant ministries for its diverse population, reaching remote workers, and addressing potential worldview diversity accompanying high education levels.

Peachtree City, a larger, established planned community, also boasts high income (\$111,421) and education levels, though slightly lower than Tyrone's, with a higher poverty rate (6.5%). It has an older median age (43.7) and a larger senior population (19.8%) compared to Tyrone. While predominantly White (70.9%), it shows growing Asian (8.1%) and Hispanic (8.2%) populations. Lower homeownership (73.0%) indicates a larger segment of renters or potentially more transient residents. Its unique golf-cart path system shapes its lifestyle. Resident satisfaction is extremely high (92%), particularly with safety and education, but surveys indicate opportunities for enhancing the sense of community and acceptance.²⁴ Ministry implications for Peachtree City involve leveraging the high quality of life, engaging both families and the significant senior population, integrating newcomers/renters, fostering deeper community connections, and addressing potential complacency linked to high satisfaction.

Both communities exist within Fayette County, where roughly 74% of the population adheres to a listed religious body, leaving a significant (~26%) unaffiliated segment.¹⁴ National trends indicate a rise in religious unaffiliation and syncretism (blending beliefs), particularly among younger generations and the highly educated.²⁵ Reaching this unaffiliated group in affluent, educated contexts like Tyrone and Peachtree City requires thoughtful, relational, and potentially intellectually engaging approaches that address questions of meaning and purpose beyond material needs. Tailored strategies focusing on community building, family support, cultural relevance, and authentic engagement are crucial for effective ministry in both municipalities over the next decade.

Key Differences and Similarities:

- **Size and Density:** Peachtree City is significantly larger in population (over 5 times) than Tyrone.¹ While Tyrone covers 12.5 square miles with a density of 624 people/sq mile ³¹, Peachtree City's larger population resides within its planned structure.
- **Affluence:** Both communities are highly affluent, substantially exceeding state and metro Atlanta averages.³¹ However, Tyrone reports a notably higher median household income and per capita income, coupled with an exceptionally low poverty rate compared to Peachtree City.¹
- **Age Structure:** Peachtree City has a slightly younger median age but a higher percentage of residents aged 65 and over compared to Tyrone.¹ Both have significant older adult populations.
- **Racial/Ethnic Composition:** Tyrone exhibits greater racial diversity, particularly with a large Black population comprising nearly a third of its residents. Peachtree City is less diverse, predominantly White (Non-Hispanic), but has larger percentages of Asian and Hispanic residents than Tyrone.¹ Peachtree City also has a significantly higher percentage of foreign-born residents.¹
- **Housing Tenure:** Tyrone displays remarkably high owner-occupancy (91.7%), indicating a very stable residential base. Peachtree City has high owner-occupancy (73.0%), but a considerably larger proportion of renters, suggesting potentially greater residential mobility for a segment of its population.¹
- **Education:** Both municipalities boast exceptionally high educational attainment, with nearly all adults having high school diplomas and roughly 60% holding bachelor's degrees or higher, figures significantly above state and metro averages.¹
- **Commuting:** Tyrone residents face slightly longer average commute times.¹ A substantial portion of Tyrone's workforce works from home (23%) ³¹, a trend likely mirrored to some extent in Peachtree City given its educated workforce, although

specific data is lacking in the snippets.

These demographic profiles highlight Tyrone as a smaller, exceptionally affluent, stable, and racially diverse town, while Peachtree City is a larger, established, affluent planned community with an older population profile, growing diversity (particularly Asian and Hispanic), and a more mixed housing tenure.

4. Population Trends and Projections (2015-2035)

4.1 Historical Growth (approx. 2015-2025)

Both Tyrone and Peachtree City have experienced consistent population growth over the past decade, building on trends established earlier.

- **Tyrone:** Between the 2010 Census (Pop: 6,879) and the 2020 Census (Pop: 7,658), Tyrone grew by approximately 11.3%.¹ Population estimates indicate continued growth, reaching 7,949 by July 2023, representing a 3.5% increase from the 2020 base.¹ This suggests steady, moderate growth in recent years.
- **Peachtree City:** Similarly, Peachtree City grew by about 11.3% between the 2010 Census (Pop: 34,364) and the 2020 Census (Pop: 38,244).³ Growth accelerated slightly post-2020, with the population reaching an estimated 40,193 by July 2023, a 5.1% increase from the 2020 base.³

This growth aligns with the broader expansion of the Atlanta metropolitan area, although potentially at a more measured pace than some faster-growing exurban counties.¹²

4.2 Projected Growth (2025-2035)

Projecting future growth relies on county-level forecasts, as municipality-specific projections extending to 2035 are less common. Both the Atlanta Regional Commission (ARC) and the Georgia Governor's Office of Planning and Budget (OPB) provide forecasts for Fayette County.¹²

- **Fayette County Context:** Fayette County's population was 119,194 in the 2020 Census.¹² ARC estimated the 2024 population at 125,384.³⁴ ARC forecasts project Fayette County will add approximately 24,591 residents between 2020 and 2050.¹² While OPB provides official county projections through 2060¹³, specific 2035 figures for Fayette County require accessing their detailed datasets.
- **Estimated 2035 Population:** Using linear interpolation based on ARC's 2020-2050 county growth forecast, Fayette County's population might reach approximately 131,500 by 2035 (calculated as $119,194 + (24,591 / 30 \text{ years} * 15 \text{ years})$). This suggests continued, albeit potentially slower, growth compared to

the rapid expansion seen in previous decades.³³

- **Implications for Municipalities:** While county-level growth is expected to be moderate, the distribution of this growth between unincorporated areas and municipalities like Tyrone and Peachtree City will depend on local development policies, housing availability, and annexation activities. Given their desirability (high incomes, good schools), both cities are likely to capture a share of this county growth, continuing their upward population trends through 2035, though perhaps not at the explosive rates seen pre-2000.³³

4.3 Projected Age Structure Changes

Regional forecasts indicate significant shifts in age structure, which will impact Fayette County, Tyrone, and Peachtree City.

- **Aging Population:** The most dramatic shift projected for the Atlanta region is the rapid growth of the older adult population. The share of residents aged 75 and over is expected to more than double, from 5% in 2020 to 12% by 2050.¹² This trend is already visible in Peachtree City, which has a higher percentage of residents 65+ (19.8%) than Tyrone (17.0%).¹
- **Implications:** Both communities, particularly Peachtree City, will likely see a continued increase in their senior populations through 2035. This necessitates consideration of services, housing, healthcare access, and ministry approaches tailored to older adults.

4.4 Projected Racial/Ethnic Diversity Changes

The Atlanta region is projected to become significantly more diverse, a trend likely reflected in Fayette County.

- **Increasing Diversity:** ARC forecasts that by 2050, nearly 62% of the Atlanta region's population will belong to racial and ethnic minority groups.¹² While Fayette County currently has a lower minority percentage than the region overall³⁶, it is diversifying.
- **Current Composition:** Tyrone already shows considerable diversity (55% White NH, 31% Black, 3% Asian, 5% Hispanic).¹ Peachtree City is less diverse (69% White NH) but has notable and growing Asian (8%) and Hispanic (8%) populations, along with a higher foreign-born percentage (15.7%).³
- **Implications:** Both municipalities are expected to become more racially and ethnically diverse by 2035, continuing current trends. This underscores the need for culturally sensitive and inclusive ministry approaches.

5. Psychographic and Lifestyle Trends

Understanding the values, attitudes, and lifestyles of residents in Tyrone and Peachtree City provides crucial context for effective community engagement. While direct psychographic surveys for Tyrone are limited in the provided materials, insights can be drawn from regional studies and data from Peachtree City.

5.1 Community Values and Character

- **Peachtree City:** Resident surveys reveal exceptionally high overall satisfaction (92%).²⁴ Key strengths driving satisfaction include the perceived sense of overall safety (90% positive rating), access to quality education (92% positive), overall cleanliness and maintenance (87% positive), and quality of parks/recreation (81% positive).²⁴ Residents value the quality of life, often citing the unique environment fostered by the extensive golf cart path system and planned village structure.²³ However, areas identified as relative weaknesses or opportunities for improvement include the "sense of community among residents" (72% positive, lower than other top metrics) and "acceptance of residents of all backgrounds" (69% positive).²⁴ Concerns also exist regarding traffic congestion and managing development.²³ The high likelihood of residents planning to stay (75% likely to be living there in 5 years) points to community stability and satisfaction.²⁴
- **Tyrone/South Fayette Context:** Insights from nearby Fairburn suggest a regional appreciation for a quieter, "small-town charm" that contrasts with denser urban environments.²² Values likely include safety, neighborliness, authenticity, and affordability (though affordability is relative in these high-income areas). The extremely high homeownership rate in Tyrone (91.7%) reinforces a value placed on stability and rootedness.¹ High educational attainment in both cities suggests residents likely value intellectual pursuits, achievement, and opportunities for their children.¹

5.2 Lifestyle Indicators

- **Affluence and Education:** High median incomes (\$133K in Tyrone, \$111K in PTC) and high percentages of residents with bachelor's degrees or higher (around 60% in both) shape lifestyles.¹ This often correlates with professional occupations, demand for high-quality services (including education), and potentially busy schedules.
- **Family Orientation:** The presence of excellent schools¹⁵ and significant populations under 18 (Tyrone 21.7%, PTC 23.6%) points to a strong family orientation in both communities.¹ Recreational amenities and community events likely cater to families.
- **Connectivity:** High rates of household computer ownership (Tyrone 96.6%, PTC 98.3%) and broadband internet subscriptions (Tyrone 95.9%, PTC 95.3%) indicate

highly connected populations, comfortable with digital communication and online engagement.¹

- **Mobility and Work:** While many commute (average times ~28-32 mins)¹, a significant portion works from home, especially noted in Tyrone (23%).³¹ Peachtree City's unique path system influences local travel and recreation.²³ Low geographic mobility is indicated in Tyrone (90% living in the same house year-over-year)³¹, suggesting stability. Peachtree City shows slightly higher mobility (87% same house)³, potentially linked to its larger renter population.
- **Quality of Life Focus:** High satisfaction ratings in Peachtree City²⁴ and regional reports emphasizing quality of life factors like safety and amenities²² suggest residents actively seek and value a high standard of living, encompassing more than just economic factors. Concerns about affordable housing²⁴ and access to affordable fresh food in some county areas³⁹ highlight potential pressures even within affluent communities.

6. Religious Landscape and Worldview Outlook

Understanding the religious and spiritual beliefs prevalent in the community is essential for tailoring ministry approaches. Data is primarily available at the Fayette County level, providing a backdrop against which municipal nuances can be considered.

6.1 Religious Affiliation (Fayette County - ARDA 2020)

The 2020 U.S. Religion Census data for Fayette County reveals a predominantly Christian landscape but with a substantial segment not affiliated with the reporting religious bodies.¹⁴

- **Overall Adherence:** Approximately 73.8% of the Fayette County population (87,984 adherents out of 119,194 residents in 2020) were affiliated with religious groups included in the census.¹⁴
- **Unaffiliated Population:** This implies that roughly 26.2% of the county's population is not accounted for by these specific religious bodies. This group likely includes those identifying as atheist, agnostic, "nothing in particular," or adherents of smaller religious groups not captured in the census.¹⁴ This represents a significant mission field.
- **Major Traditions (Estimated County Adherence Rates):**
 - Evangelical Protestant: ~37.0% (Largest groups: Southern Baptist Convention, Non-denominational Christian Churches, Christian Churches/Churches of Christ)¹⁴
 - Catholic: ~18.2%¹⁴

- Mainline Protestant: ~10.4% (Largest group: United Methodist Church) ¹⁴
- Historically Black Protestant: ~0.8% (Groups like AME, Progressive National Baptist, COGIC reported relatively small numbers in the county census) ¹⁴
- Other Faiths: ~7.4% (Includes Latter-day Saints, Jehovah's Witnesses, Muslim Estimate, Jewish groups, Orthodox, Baha'i, etc.) ¹⁴

It is important to note that the racial composition of Tyrone (31% Black) suggests that the Historically Black Protestant adherence rate might be higher within Tyrone itself than the county-wide average indicates, potentially drawing from congregations located just outside the town limits or within the broader county. Non-denominational churches also represent a significant portion of the evangelical landscape.¹⁴

6.2 Worldview Outlook Trends (National and Georgia Context)

National and state-level research on worldview provides context for understanding the likely beliefs and values within Tyrone and Peachtree City, particularly among the educated and unaffiliated segments.

- **Decline in Traditional Belief:** Research by Barna indicates a significant decline in belief in the God of the Bible nationally, dropping from 73% in the early 1990s to just 40% currently.²⁵ While a majority still believe in a supreme power, the understanding of that power is shifting away from traditional Judeo-Christian concepts.²⁵ Pew Research Center data for Georgia (2023-24) shows 67% identify as Christian, but a large and growing portion (26%) identify as religiously unaffiliated (atheist, agnostic, or "nothing in particular").²⁶
- **Rise of Syncretism:** Syncretism, the blending of elements from multiple worldviews, is identified by Barna as the dominant worldview in America (92% incidence).²⁷ Many individuals, including some identifying as Christian, mix beliefs from contradictory traditions, constructing personalized spiritualities.²⁵ This suggests a cultural environment where spiritual flexibility and individual definition of truth are common.²⁵
- **Generational Differences:** Biblical worldview adherence is significantly lower among younger generations (Millennials 2%, Gen Z 1%) compared to older generations (Boomers 8%, Gen X 5%).²⁸ Worldviews are largely formed by age 13, highlighting the importance of early spiritual formation.²⁵
- **Implications for Tyrone and Peachtree City:** Given the high levels of education and affluence in both municipalities, residents (especially younger adults and the unaffiliated) are likely influenced by these national trends. We can anticipate a mix of worldviews: traditional biblical theism, various forms of Christianity potentially influenced by syncretism, other world religions (reflecting growing diversity), and a significant segment holding agnostic, atheistic, or vaguely spiritual ("spiritual

but not religious," "higher power") beliefs.²⁶ Outreach and discipleship efforts need to be prepared to engage with this complex and often individualized spiritual landscape, moving beyond assumptions of shared traditional beliefs. Addressing questions of meaning, purpose, and truth in intellectually honest ways will be crucial.

7. Educational Landscape

The quality of local schools is a significant factor influencing community character, attracting families, and shaping resident values. Both Tyrone and Peachtree City are served primarily by the highly-regarded Fayette County Public Schools district.

7.1 School District Overview

Fayette County Public Schools serves both municipalities and is ranked as the #4 Best School District in Georgia by Niche.com, receiving an overall grade of 'A'.⁴¹ The district comprises 24 schools serving over 20,000 students.⁴¹ Reviews highlight the district's focus on safety, educational resources, and preparing students for the future, although some note a desire for more responsiveness to individual concerns.⁴¹ The high ranking and positive perception of the district are major assets for both communities. Some areas near Tyrone might also be zoned for Coweta County Schools (#33 in GA, Grade A-) or Fulton County Schools.¹⁵

7.2 School Ratings - Tyrone

Public schools serving Tyrone consistently receive high ratings, contributing to the town's appeal for families.¹⁵

- **High Schools:**

- *McIntosh High School:* Rated A+, ranked #17 in Georgia. Noted for academic and athletic competitiveness.¹⁵
- *Sandy Creek High School:* Rated B+, ranked #136 in Georgia. Strong in CTE and music programs.¹⁵

- **Middle Schools:**

- *Booth Middle School:* Rated A, ranked #22 in Georgia.¹⁵
- *Flat Rock Middle School:* Rated A, ranked #68 in Georgia.¹⁵

- **Elementary Schools:**

- *Crabapple Lane Elementary School:* Rated A, ranked #43 in Georgia. Praised for academic rigor.¹⁵
- *Robert J. Burch Elementary School:* Rated A-, ranked #231 in Georgia.¹⁵

- (Note: Niche lists schools based on geographic proximity, sometimes including charter schools or schools from adjacent districts like Coweta Charter (A-), Wolf

*Creek Elem (Fulton, B+), Odyssey Charter (Coweta, B).*¹⁵⁾

- **Overall:** The public schools accessible to Tyrone residents are generally excellent, reflecting the high quality of the Fayette County district.

7.3 School Ratings - Peachtree City

Peachtree City boasts an exceptionally strong roster of highly-rated public schools across all levels.¹⁹

- **High Schools:**
 - *McIntosh High School:* Rated A+, ranked #17 in Georgia.¹⁹
 - *Starrs Mill High School:* Rated A, ranked #27 in Georgia. Considered well-rounded.¹⁹
 - *Fayette County High School:* Rated B+, ranked #113 in Georgia.¹⁹
- **Middle Schools:**
 - *Rising Starr Middle School:* Rated A, ranked #17 in Georgia.¹⁹
 - *Booth Middle School:* Rated A, ranked #22 in Georgia.¹⁹
 - *Flat Rock Middle School:* Rated A-, ranked #68 in Georgia.¹⁹
 - *Bennett's Mill Middle School:* Rated A-, ranked #89 in Georgia.¹⁹
- **Elementary Schools:** Numerous elementary schools receive 'A' ratings, including:
 - *Kedron Elementary:* Rated A, ranked #16 in Georgia.¹⁹
 - *Braelinn Elementary:* Rated A, ranked #36 in Georgia.¹⁹
 - *Peachtree City Elementary:* Rated A, ranked #40 in Georgia.¹⁸
 - *Crabapple Lane Elementary:* Rated A, ranked #43 in Georgia.¹⁹
 - *Peebles Elementary:* Rated A, ranked #64 in Georgia.¹⁹
 - *Oak Grove Elementary:* Rated A, ranked #87 in Georgia.¹⁹
 - *Huddleston Elementary:* Rated A, ranked #141 in Georgia.¹⁹
 - *Cleveland Elementary:* Rated A-, ranked #244 in Georgia.¹⁹
- **Overall:** Peachtree City offers outstanding public education options at every level, a key factor in its high quality of life ratings.

7.4 Implications for Church Ministry

The exceptional quality of public schools in both Tyrone and Peachtree City has direct implications for church strategy.

- **Family Attraction and Ministry Focus:** The strong school system is undoubtedly a primary draw for families moving into the area. This reinforces the demographic data showing significant populations under 18. Churches have a clear opportunity and likely expectation to provide robust, high-quality ministries for children and youth. Supporting families through parenting resources, marriage enrichment, and programs that align with the school calendar can meet felt needs and build

connections.

- **Community Engagement and Partnership:** The central role of schools in community life offers avenues for positive church engagement. Opportunities include supporting school events, providing volunteers for tutoring or mentoring programs (where permissible), appreciating teachers and staff, and potentially offering facility use. Such partnerships demonstrate a church's commitment to the community's well-being and values, building goodwill and visibility. This aligns with the desire for a strong "sense of community" noted in surveys.²⁴

8. Strategic Implications for Church Leadership: Tyrone

8.1 Synthesized Profile

Tyrone presents as a relatively small but rapidly growing municipality characterized by exceptional affluence (Median HH Income \$133,773), very high educational attainment (60% Bachelor's+), and an extremely low poverty rate (2.1%).¹ It is notably diverse, with a majority White population (55%) coexisting with a large Black population (31%) and smaller Asian (3%) and Hispanic (5%) communities.¹ The community values stability, evidenced by extremely high homeownership (92%) and low residential turnover.¹ Excellent schools are a key asset.¹⁵ A significant portion of the workforce (23%) works remotely.³¹ While situated in a county with high overall religious adherence, the national trends toward unaffiliation and worldview diversification likely apply here, particularly given the high education levels.¹⁴ Residents likely prioritize education, family, stability, and professional achievement.

8.2 Opportunities

- **Engage High-Capacity Individuals:** The high concentration of educated and affluent residents represents a potential pool for leadership, skilled volunteerism, and financial support for ministry initiatives. Engagement strategies should respect their likely busy schedules and potentially high expectations for quality and impact.
- **Culturally Relevant and Diverse Ministry:** The significant presence of both White and Black residents, along with growing Asian and Hispanic communities, necessitates intentional efforts to create ministries and outreach that resonate across cultures. Fostering diverse leadership within the church is crucial for authentic connection and representation.
- **Build on Community Stability:** The high homeownership rate and low turnover suggest residents are invested in the community long-term.¹ This creates opportunities for building deep relationships, long-term discipleship programs, and ministries that foster intergenerational connections.

- **Connect with Remote Workers:** The substantial remote workforce presents unique opportunities.³¹ Churches could consider offering weekday connection points, leveraging technology for online community building, or even providing resources like co-working spaces or professional networking events integrated with faith discussions.
- **Address Worldview Diversity:** The highly educated populace likely harbors a spectrum of worldviews, from traditional faith to syncretism, agnosticism, or atheism.²⁵ This calls for ministries that engage thoughtfully with complex questions of faith, science, ethics, and meaning, offering intellectual depth alongside relational connection. Forums, Q&A sessions, and small groups exploring challenging topics could be effective.

8.3 Challenges

- **Potential Self-Sufficiency Mindset:** Exceptional affluence and achievement can sometimes foster a mindset of self-reliance, making it challenging for individuals to recognize spiritual needs or engage deeply in community care that requires vulnerability. Ministry approaches may need to emphasize purpose, meaning, and connection over solely addressing material needs.
- **Bridging Cultural Divides:** While diversity is a strength, ensuring genuine integration, mutual understanding, and shared belonging across different racial and cultural groups requires intentional programming, diverse leadership, and fostering cross-cultural relationships. Avoiding unintentional segregation within church life is paramount.
- **Reaching Affluent Unaffiliated:** Connecting with religiously unaffiliated individuals in such a high-income, highly educated context may require approaches different from those used in areas with more apparent material needs. Outreach might focus on intellectual engagement, addressing existential questions, demonstrating community value through high-impact service, and building authentic relationships based on shared interests or life stages.

8.4 Recommendations for Ministry & New Congregations

- **Outreach Strategies:**
 - *Relational & Intellectual Focus:* Emphasize building genuine relationships. Offer intellectually stimulating events (e.g., forums on current issues from a faith perspective, guest speakers).
 - *Community Value Demonstration:* Partner visibly with schools or local initiatives that align with community values (family, education, stability).
 - *Digital Engagement:* Leverage the high internet connectivity¹ for sophisticated online presence, targeted digital outreach, and online

community options.

- **Ministry Focus Areas:**

- *Family & Youth:* Maintain excellent, engaging programs for children and youth, aligning with the community's focus on education and family. Provide robust parenting support.
- *Marketplace Ministry:* Develop programs that help professionals integrate faith and work, addressing the large segment of educated residents.
- *Culturally Specific Groups:* Offer small groups or ministries tailored to the needs and cultural contexts of the diverse population segments (e.g., Black, White, Asian, Hispanic).
- *Deep Discipleship:* Capitalize on residential stability by offering in-depth discipleship pathways that foster long-term spiritual growth.

- **Community Engagement:**

- *School Partnerships:* Actively seek ways to support local schools through volunteering, appreciation events, or resource provision.
- *Cross-Cultural Events:* Host community events designed to foster connection and understanding between diverse resident groups.
- *Professional Life Resources:* Offer workshops or groups related to career development, work-life balance, or ethical leadership.

- **New Congregation Considerations:**

- *Focus/Type:* A new congregation could be specifically designed to appeal to professionals and families, emphasizing intellectual depth, authentic community, and high-quality programming. A multi-ethnic model intentionally bridging the White and Black communities could meet a significant need. Alternatively, a focus on deep community building could counter potential isolation in an affluent suburban setting.
- *Style:* The presentation, music, and teaching would likely need to be high-quality and culturally relevant to an educated, diverse audience. Contemporary styles might be common, but theological substance is crucial.
- *Location:* Strategic placement within Tyrone, easily accessible to its residential areas, would be important.

9. Strategic Implications for Church Leadership: Peachtree City

9.1 Synthesized Profile

Peachtree City is a large, well-established, affluent (Median HH Income \$111,421) planned community known for its high quality of life and extensive golf cart path network.³ Educational attainment is exceptionally high (60% Bachelor's+) and public schools are top-rated.³ The population is older on average (Median Age 43.7) with a

significant senior segment (19.8% 65+).³ While predominantly White (69% NH), the city is diversifying, with growing Asian (8%) and Hispanic (8%) populations and a notable foreign-born segment (15.7%).³ Homeownership is high (73%) but lower than Tyrone, indicating a larger renter population (~27%) and potentially more transience.³ Resident satisfaction is extremely high (92%), valuing safety, education, and amenities, yet opportunities exist to strengthen the "sense of community" and "acceptance of all backgrounds".²⁴ Despite high satisfaction, a significant unaffiliated population (~26% in the county) exists within this context¹⁴, likely influenced by national worldview trends.²⁵

9.2 Opportunities

- **Leverage High Quality of Life:** Churches can align with the city's positive image by offering excellent programs, maintaining attractive facilities (if applicable), and actively contributing to the community's valued characteristics (safety, family-friendliness, recreation).
- **Engage Families and Seniors:** The combination of top-rated schools¹⁹ and a large, growing senior population³ presents clear opportunities for targeted family, youth, and senior adult ministries, addressing the distinct needs and interests of these life stages.
- **Connect with Newcomers and Renters:** The sizable renter population (approx. 27%)³ suggests a segment that may be less connected or more transient. Developing specific welcome initiatives, social events, and small groups tailored for newcomers can foster integration and belonging.
- **Address Community Gaps:** Churches can play a vital role in strengthening the areas identified as relative weaknesses in resident surveys: "sense of community" and "acceptance of residents of all backgrounds".²⁴ Ministries focused on building authentic relationships, fostering cross-cultural understanding, and creating inclusive environments can meet these needs.
- **Utilize Unique Lifestyle:** The pervasive golf cart path system offers unique engagement possibilities. Churches could consider organizing small groups accessible by cart, hosting events near path access points, or incorporating the outdoor lifestyle into ministry activities.

9.3 Challenges

- **Potential Complacency:** Extremely high resident satisfaction²⁴ and general affluence might lead to a sense of complacency or a feeling that spiritual resources are unnecessary. Demonstrating relevance and addressing deeper human needs beyond comfort and amenities is crucial.
- **Planned Community Structure:** The distinct village structure of Peachtree City

²³, while offering identity, could potentially create social silos. Connecting residents from different villages and fostering a unified sense of community may require intentional effort.

- **Reaching the Margins:** Within a largely affluent and satisfied community, intentionally identifying and serving those experiencing hardship (e.g., the 6.5% in poverty ³, those feeling excluded ²⁴, or those struggling despite outward appearances) requires sensitivity and specific strategies.
- **Affordability Issues:** High housing costs (Median Value \$461K, Median Rent \$1,915) ³ and resident dissatisfaction with affordable housing availability ²⁴ can create barriers for younger families, service workers essential to the community, and potentially church staff, impacting diversity and accessibility.

9.4 Recommendations for Ministry & New Congregations

- **Outreach Strategies:**
 - *Relationship & Community Focus:* Prioritize building authentic relationships and demonstrating a commitment to the broader community's well-being.
 - *Family & Quality of Life Alignment:* Host high-quality, family-friendly events and initiatives that align with the city's valued lifestyle (e.g., "Love Peachtree City" service projects, recreational events).
 - *Addressing Deeper Questions:* Engage the educated populace with discussions on meaning, purpose, ethics, and navigating life's challenges, moving beyond surface-level satisfaction.
 - *Digital Presence:* Maintain a strong digital presence for communication and connection, given high internet usage.³
- **Ministry Focus Areas:**
 - *Life Stage Ministries:* Robust programs for children, youth, families, and seniors are essential.
 - *Newcomer Integration:* Specific programs to welcome and connect newcomers and renters into the church and community.
 - *Community-Building Groups:* Small groups designed intentionally to foster deep relationships and bridge social divides (potentially across villages or demographics).
 - *Meaning & Purpose Exploration:* Ministries addressing existential questions and helping people find purpose beyond material success.
 - *Benevolence/Support:* Discreet and dignified ways to support those facing economic hardship within the community.
- **Community Engagement:**
 - *Visible Partnerships:* Collaborate with schools, city event organizers, and local non-profits to be a visible, positive contributor.

- *Events Fostering Connection:* Host events specifically designed to build community and promote cross-cultural understanding, addressing the identified gaps.²⁴
- *Utilize Amenities:* Leverage parks and paths for outreach events or group activities where appropriate.
- **New Congregation Considerations:**
 - *Focus/Type:* A new church could target specific life stages prominent in PTC (e.g., young families drawn by schools, or active empty nesters/seniors). A strong emphasis on building authentic community could resonate deeply. A multi-ethnic focus could proactively address growing diversity and the "acceptance" gap.²⁴ Models emphasizing practical service and community betterment might also fit well.
 - *Style:* Needs to align with the high expectations of the community – likely high-quality in execution, family-friendly, and authentic in its message and relationships. Could range from contemporary to traditional liturgical depending on the target demographic.
 - *Location:* Strategic location within or near specific villages, considering accessibility via roads and potentially the path system, is important. Utilizing existing community spaces initially could be viable.

10. Conclusion

Tyrone and Peachtree City, while sharing characteristics of affluence and high educational attainment within Fayette County, present distinct community profiles requiring tailored ministry strategies. Tyrone is smaller, exceptionally affluent, residentially stable, and notably diverse, particularly with significant White and Black populations. Peachtree City is a larger, established planned community with an older demographic profile, high overall resident satisfaction tied to its unique lifestyle and amenities, growing diversity (especially Asian and Hispanic), and a larger segment of renters compared to Tyrone.

Both municipalities exist within a county and national context marked by a significant and growing religiously unaffiliated population. National trends point towards declining adherence to traditional biblical beliefs and a rise in syncretism and personalized spirituality, particularly among educated populations. Therefore, church leadership in both Tyrone and Peachtree City faces the dual task of nurturing existing faith communities while developing relevant and effective strategies to connect with the substantial number of residents not currently engaged with a church.

Effective ministry over the next decade will necessitate moving beyond one-size-fits-all approaches. In Tyrone, strategies should embrace its diversity, engage high-capacity residents intellectually and relationally, leverage community stability, and connect with the remote workforce. In Peachtree City, approaches should align with the high quality of life, intentionally build deeper community connections to address identified gaps in resident surveys, engage both families and the large senior population, and develop pathways for integrating newcomers and renters.

Ultimately, success in reaching both established residents and the unaffiliated in these desirable suburban communities will likely hinge on demonstrating authentic faith, fostering genuine community, addressing relevant life questions with intellectual honesty, and actively contributing to the common good in ways that resonate with local values. By prayerfully considering these demographic realities, psychographic nuances, and worldview trends, the church leadership team can strategically position its ministries for impactful engagement and growth in Tyrone and Peachtree City through 2035 and beyond.
